### **Rationale**

- Busan HLF 4 Busan Partnership for Effective Development Cooperation
  - Affirming unfinished aid effectiveness agenda;
  - Inclusive partnership (civil society organisations, private sector engagement);
  - Focusing on country-led results framework;
  - Global-light, country-heavy (country focus): emphasis on countrylevel implementation and monitoring
  - Mutual accountability (global monitoring on key selective indicators);
- Working Party on Aid Effectiveness at the end of June expected to endorse the final proposal on the new global monitoring framework
- DPAF exercise in the past weakness of some of the indicators

# **Revised DPAF Indicators and Targets**

- Incorporates:
  - Busan Partnership Global Monitoring Framework (indicators that are to be monitored at country level, aggregated at global level)
  - Important indicators based on country-needs Country-heavy
  - Remove indicators that are not appropriately informing the issues
  - No change to the Division of Labour related indicators
  - No change to the DPAF for Budget Support adopted at the JBSR May 2012
  - Targets based on Post-Busan global monitoring targets (baseline 2010) and based on Rwanda Aid Policy

15 August	DPs to enter data for DPAF in the DAD for FY 2011/2012
31 August	GoR verification and bilateral consultation based on raw DAD data
Early Sept	Preliminary DPAF results shared with DPs
Mid-Sept	Bilateral discussions on preliminary DPAF results and revisions made by DPs
End Sept	Revised DPAF Results circulated
Mid Oct	DPCG to discuss the final draft DPAF aggregate and individual DP results
End Oct	Necessary revisions made
End Oct	Finalize the DPAF Reports
