a) Each donor to communicate 3 measurable actions to meet DPAF targets over the next year to MINECOFIN (all bilateral and multilateral partners)	- by end April 09	Partially Completed – 4 out of 14 DPs (28.6%) did not communicate them (AfDB, GF, Japan, Switzerland)
b) Each donor to communicate in writing, for each project not relying fully on national PFM and procurement systems, reasons for this and steps in place to change (all bilateral and multilateral partners)	- by end April 09	Partially completed – 5 out of 14 (35.7%) did not communicate them:AfDB, GF, Japan, Switzerland, UN
